Dear City of Defiance Residents and Businesses,

The City of Defiance is pleased to announce it has selected Dynegy as the preferred electricity supplier for the City's Electric Aggregation Program. Voters approved the formation of an opt-out aggregation program in November 2000, allowing City of Defiance officials to bring together residential and small commercial community members to gain group-buying power for the purchase of electricity from a certified retail electric supplier. Both the City of Defiance and Dynegy are certified by the Public Utilities Commissions of Ohio.

As an eligible resident or small business, you will be automatically enrolled in the program unless you choose to opt-out (not participate) by **March 4, 2024.** The aggregation program for the City of Defiance will begin within one to two billing periods following your inclusion as a participant in the City of Defiance program and will end with your December 2025 meter reading.

## Program Details:

- Fixed Electricity Price of \$0.063770 per kWh through your December 2025 meter reading.
- One energy bill from Toledo Edison, your local electricity provider.
- No Fee to cancel at any time.
- By receiving this letter, you do not need to do anything to be a part of the program.
- Toledo Edison continues to deliver your electricity and maintain the electric lines and respond to emergencies.

## **Program Enrollment**

After your enrollment is finalized, Toledo Edison will send you a letter confirming your enrollment. As required by law, this letter will inform you of your ability to rescind your enrollment with no penalty. If you wish to participate in the Program, you do not need to take any action when you receive the letter confirming your enrollment.

## **How to Opt-Out**

If you do not wish to participate, you must opt-out no later than **March 4**, **2024**. You can do this by completing and returning the reply card below or by calling 888-682-2170.

If you choose to opt out (not participate), you may do so at no charge during this initial enrollment period and you will not be served by Dynegy. If you become part of the aggregation, you may cancel the agreement at any time at no charge by providing notice to Dynegy. If you choose to opt out of the program at this time, or if you choose to leave the program at a later date, you will be served by your utility under its standard service offer or until you choose an alternative supplier. If you switch back to your utility, you may not be served under the same rates, terms, and conditions that apply to other customers served by your utility.
