Dear Pierce Township Residents and Businesses,

Pierce Township is providing you with the opportunity to participate in the Township's Electric Governmental Aggregation Program. Savings are possible through a concept called government aggregation, where Township officials bring together citizens to gain group-buying power for the purchase of Electric from a retail supplier. Both the Township and supplier are certified by the Public Utilities Commissions of Ohio. Township voters approved this program in November 2018. The aggregation program for Pierce Township will begin within one to two billing periods following your inclusion as a participant in the Township's program and end with you June 2021 meter reading. As an eligible resident or small business, you will be automatically enrolled in the program unless you choose to opt-out (not participate) by May 13, 2019

During the past few months, we have researched options for competitive electric pricing for you. Pierce Township is pleased to announce it has selected Dynergy as the preferred electricity supplier for its program.

### Program Details:

- **Fixed Electricity Price** of \$0.04985 per kWh through your June 2021 meter reading.
- **One energy bill** from Duke Energy, your local utility provider.
- **No Fee** to cancel at any time.
- By receiving this letter, you **do not need to do anything** to be a part of the program.
- Duke Energy continues to deliver your electricity and maintain the electric lines and respond to emergencies.

### Program Enrollment

After your enrollment is finalized, Duke Energy will send you a letter confirming your enrollment. As required by law, this letter will inform you of your ability to rescind your enrollment with no penalty.

### How to Opt-Out

If you do not wish to participate, you must opt-out no later than **May 13, 2019**. You can do this by completing and returning the reply card below or by calling 888-682-2170.

If you choose to opt out (not participate), you may do so at no charge during this initial enrollment period and you will not be served by Dynergy. If you become part of the aggregation, you may cancel the agreement at any time at no charge by providing notice to Dynergy. If you choose to opt out of the program at this time, or if you choose to leave the program at a later date, you will be served by your utility under its standard service offer or until you choose an alternative supplier. If you switch back to your utility, you may not be served under the same rates, terms, and conditions that apply to other customers served by your utility.
